Notes on Copyright for Contributors to *The Forestry Chronicle*

Note 1

CIF/IFC, as publisher, requires an assignment of copyright from authors for several reasons:

- a) it helps to protect the material published by CIF/IFC from unauthorized copying;
- b) it helps CIF/IFC to deal expeditiously with requests from third parties to reproduce the material.

Note 2

If the work was created by an author while he or she was an employee of an institution or corporations, then copyright may belong to the employer. In such case, option 4 (c) will apply and the employer's authorized officer must sign the form.

Note 3

Certain governments, such as the Canadian and British government, retain copyright ownership in work created by their employees and do not have a simple mechanism for assigning copyright. In such case, option 4(d) will apply and CIF/IFC will accept a licence from the authorized officer of the government body.
